Introduction 1.

Purpose of this chapter 1.1

- 1.1.1 This chapter of the Preliminary Environmental Information Report (PEIR) presents the initial findings of the Environmental Impact Assessment (EIA) work undertaken to date concerning potential impacts of Thurrock Flexible Generation Plant on noise and vibration.
- 1.1.2 The PEIR is being published to inform pre-application consultation comments. Following consultation, comments on the PEIR will be reviewed and taken into account in preparation of the Environmental Statement (ES) that will accompany the application to the Planning Inspectorate (PINS) for development consent.
- 1.1.3 This chapter assesses the potential noise and vibration effects on surrounding noise and vibration sensitive receptors (NVSRs) as a result of the construction, operation and decommissioning of the proposed development.
- 1.1.4 This chapter begins by setting out the policy, legislative context and relevant standards and guidance for the assessment. The methods and criteria used to assess potential adverse noise and vibration effects are then described. Baseline conditions at receptors potentially impacted by the development are described. Conclusions have been drawn as to the significance of the residual effects.
- 1.1.5 This chapter summarises information contained within technical appendices, which are included at Volume 6, Appendix 11.3: Construction Noise Assessment Methodology and Results and Appendix 11.4: Operational Noise Assessment Methodology and Results.
- In particular, this PEIR chapter: 1.1.6
 - presents the existing environmental baseline established from desk studies, • surveys and consultation to date;
 - presents the potential environmental effects of noise and vibration arising from Thurrock Flexible Generation Plant, based on the information gathered and the analysis and assessments undertaken to date;
 - identifies any assumptions and limitations encountered in compiling the • environmental information; and
 - highlights any necessary monitoring and/or mitigation measures that could prevent, minimise, reduce or offset the possible environmental effects identified in the EIA process.

Planning policy context 1.2

- 1.2.1 Planning policy for energy generation Nationally Significant Infrastructure Projects (NSIPs), specifically in relation to noise and vibration, is contained in the Overarching National Policy Statement (NPS) for Energy (EN-1; DECC, 2011a) and the NPS for Fossil Fuel Electricity Generating Infrastructure (EN-2, DECC, 2011b).
- 1.2.2 NPS EN-1 and NPS EN-2 include guidance on what matters are to be considered in the assessment. These are summarised in Table 1.1 below.

National Planning Policy Framework

The National Planning Policy Framework (NPPF) sets out the Government's planning 1.2.5 policies for England and how these are expected to be applied. The emphasis of the Framework is to allow development to proceed where it can be demonstrated to be sustainable. In relation to noise, Paragraph 180 of the Framework states that:

> "Planning policies and decisions should ensure that new development is appropriate for its location taking into account the likely effects (including cumulative effects) of pollution on health, living conditions and the natural environment, as well as the potential sensitivity of the site or the wider area to impacts that could arise from the development. In doing so they should:

> a) mitigate and reduce to a minimum potential adverse impacts resulting from noise from the development – and avoid noise giving rise to significant adverse impacts on health and the quality of life;

b) identify and protect tranquil areas which have remained relatively undisturbed by noise and are prized for their recreational and amenity value for this reason; and

c) limit the impact of light pollution from artificial light on local amenity, intrinsically dark landscapes and nature conservation."

1.2.6 The point 'a)' refers to 'significant adverse impacts' which relates to the 'significant observed adverse effect level' (SOAEL) in the Noise Policy Statement for England (NPSE). Although the term 'effect' is used instead of the term 'impact' these are considered to be interchangeable in this context.

National Planning Practice Guidance – Noise (NPPG)

1.2.7 The NPPG reiterates general guidance on noise policy and assessment methods provided in the NPPF, Noise Policy Statement for England (NPSE) and British Standards (BS), and contains examples of acoustic environments commensurate with various effect levels. It is considered appropriate to NSIPs. A summary of the guidance from the NPSE and NPPG is set out in Table 1.3.

- 1.2.8 The NPPG describes noise that is not noticeable to be at levels below the No Observed Effect Level (NOEL). It describes a range of noise exposure that is noticeable but not to the extent there is a perceived change in quality of life. Noise exposures in this range are below the Lowest Observed Adverse Effect Level (LOAEL) and need no mitigation. On this basis, the audibility of noise from a development is not an appropriate criterion to judge noise effects.
- 1.2.9 The NPPG advises that noise exposures above the LOAEL cause small changes in behaviour. Examples of noise exposures above the LOAEL provided in the NPPG include:
 - having to turn up the volume on the television;
 - needing to speak more loudly to be heard; or
 - because of the noise.
- In line with the NPPF and NPSE, the NPPG states that consideration needs to be given 1.2.10 to mitigating and minimising effects above the LOAEL but taking account of the economic and social benefits being derived from the activity causing the noise.
- The NPPG advises that noise exposures above the Significant Observed Adverse 1.2.11 Effect Level (SOAEL) cause material changes in behaviour. An example of noise exposures above the SOAEL provided in the NPPG are:
 - time: or
 - avoiding certain activities during periods when the noise is present. ٠
- 1.2.12 In line with the NPPF and NPSE, the NPPG states that effects above the SOAEL should be avoided and that whilst the economic and social benefits derived from the activity causing the noise must be taken into account, such exposures are undesirable.

Noise Policy Statement for England

1.2.13 The Noise Policy Statement for England (NPSE) (Defra, 2010), aims to provide clarity regarding current policies and practices to enable noise management decisions to be made within the wider context, at the most appropriate level, in a cost-effective manner and in a timely fashion. Paragraphs 1.6 and 1.7 of the NPSE set out the long term vision and aims of Government noise policy:

"Noise Policy Vision

Promote good health and a good quality of life through the effective management of noise within the context of Government policy on sustainable development."

"Noise Policy Aims

Through the effective management and control of environmental, neighbour and neighbourhood noise within the context of Government policy on sustainable development:

- avoid significant adverse impacts on health and quality of life;
- mitigate and minimise adverse impacts on health and quality of life; and
- where possible, contribute to the improvement of health and guality of life."
- 1.2.14 The aims of the policy differentiate between noise impacts on health (e.g. sleep disturbance, hypertension, stress etc.) and noise impacts on quality of life (e.g. amenity, enjoyment of property etc.). The aims also differentiate between "significant adverse impacts" and "adverse impacts". The explanatory note to the NPSE clarifies that a significant adverse impact is deemed to have occurred if the "Significant Observed Adverse Effect Level" (SOAEL) is exceeded. An adverse effect, on the other hand, lies between the "Lowest Observed Adverse Effect Level" (LOAEL) and the SOAEL.
- 1.2.15 The aims require that all reasonable steps should be taken to avoid, mitigate and minimise adverse effects on health and quality of life whilst also taking into account the guiding principles of sustainable development, which include social, economic, environmental and health considerations.

Thurrock Council Core Strategy

1.2.16 The Thurrock Council Core Strategy and Policies for Management of Development was adopted in January 2015. The document contains the following policies with regards to noise that are relevant to the proposed development:

> "PMD1 – Minimising Pollution and Impacts on Amenity, Health, Safety and the Natural Environment

> 1. Development will not be permitted where it would cause or is likely to cause unacceptable effects on:

- *i. the amenities of the area:*
- *ii. the amenity, health or safety of others;*
- iii. the amenity, health or safety of future occupiers of the site; or
- iv. The natural environment.

2. Particular consideration will be given to the location of sensitive land uses, especially housing, schools and health facilities, and national, regionally and locally designated biodiversity sites, and areas of recreational and amenity value which are relatively undisturbed by noise and valued for this reason.

3. The Council will require assessments to accompany planning application where it has reasonable grounds to believe that a development may suffer from, or cause:

i. Air pollution;

ii. Noise pollution;

[.../...]"

"PMD9 – Road Network Hierarchy

The Council will only permit the development of new accesses or increased use of existing accesses where:

...vii. The development will minimise adverse impacts on the quality of life of local residents, such as noise, air pollution, and the general street environment.

..."

Legislation 1.3

1.3.1 Details of how the proposed development is compliant with relevant legislation are provided in Table 1.4.



Control of Pollution Act

- 1.3.2 Section 60, Part III of the Control of Pollution Act (CoPA) refers to the control of noise (including vibration) on construction sites. It provides legislation by which local planning authorities can control noise from construction sites, by stopping activities if necessary, to prevent noise disturbance occurring. In addition, it recommends that guidance provided by British Standard (BS) 5228:2014 'Code of practice for noise and vibration control on construction and open sites – Parts 1&2' (British Standards Institute, 2014), is implemented to ensure compliance with Section 60. The CoPA provides the local planning authority, in whose area work is going to be undertaken, or is being undertaken, with the power to serve a notice imposing requirements as to the way in which construction works are to be carried out. This notice can specify the plant or machinery that is or is not to be used, the hours during which the construction work can be carried out, the level of noise and vibration that can be emitted from the premises in question or at any specified point on these premises or that can be emitted during specified hours, or for any change of circumstances.
- 1.3.3 Section 61, Part III of the CoPA refers to prior consent for work on construction sites. It provides a method by which a contractor can apply for consent to undertake construction works in advance. If consent is given, and the stated method and hours of work are complied with, then the local authority cannot take action under Section 60.
- 1.3.4 Section 71, Part III of the CoPA refers to the preparation and approval of codes of practice for minimising noise. The current, June 2014, version of BS 5228 is one such approved code.
- 1.3.5 Section 72, Part III of the CoPA refers to 'best practicable means' (BPM), which is defined as:

"reasonably practicable, having regards among other things to local conditions and circumstances, to the current state of technical knowledge and to the financial implications'. Whilst 'Means' includes 'the design, installation, maintenance and manner and periods of operation of plant and machinery, and the design, construction and maintenance of buildings and acoustic structures."

If BPM is applied, then it can provide a defence against prosecution by the consenting 1.3.6 body, usually the local authority.

Environmental Protection Act 1990, Part III (EPA)

The Environmental Protection Act 1990 (EPA) deals with statutory nuisance, including 1.3.7 noise.

- 1.3.8 Section 79, Part III of the EPA, 'Statutory nuisances and inspections therefor', places a duty on local authorities to regularly inspect their areas to detect whether a statutory nuisance exists.
- 1.3.9 Where a local authority is satisfied that a statutory nuisance does exist, or is likely to occur or recur, it must serve an abatement notice. Section 80, Part III of the EPA, 'Summary proceedings for statutory nuisances', provides local authorities with the power to serve an abatement notice requiring the abatement of the nuisance or prohibiting or restricting its occurrence or recurrence; and/or carrying out such works or other action necessary to abate the nuisance.
- Section 82, Part III of the EPA, 'Summary proceedings by persons aggrieved by 1.3.10 statutory nuisances', allows a Magistrates' court to act on a complaint made by any person on the grounds that they are aggrieved by a statutory nuisance, such as noise.
- The procedures for appeals against abatement notices are detailed in the Statutory 1.3.11 Nuisance (Appeals) Regulations 1995.
- 1.3.12 Table 1.4 provides a summary of how the proposed development demonstrates compliance with the relevant legislation.

2. **Assessment approach**

2.1 **Relevant guidance and standards**

- 2.1.1 The chapter has followed the methodology set out in Volume 2, Chapter 4: Environmental Impact Assessment Methodology. The following standards and guidance documents, specific to the noise and vibration assessment have also been considered:

 - Design Manual for Roads and Bridges, Volume 11, Section 3, Part 7 'Noise and • Vibration' (Highways Agency, 2011);
 - Calculation of Road Traffic Noise (Department of Transport, 1998); •
 - Guidelines for Community Noise (World Health Organisation (WHO), 1999);
 - Night Noise Guidelines for Europe (World Health Organisation, 2009); and
 - International Standard (ISO) 9613-2:1996 'Acoustics: Attenuation of sound during • propagation outdoors. Part 2: General method of calculation' (ISO, 1996).
- 2.1.2 Further information on the above Standards and guidance documents can be found in Volume 6, Appendix 11.5: Standards and Guidance Relevant to Noise and Vibration.

2.2 **Baseline studies**

2.2.1 This section provides information on the baseline studies undertaken in order to inform the basis of the noise and vibration assessment.

Desktop study

2.2.2 Information on potential sources of noise and vibration within the surrounding area of the proposed development was collected through a detailed desktop review of the data sources summarised within Table 2.1.

Site-specific surveys

- 2.2.3 In order to inform the noise assessment, and supplement the desktop study, the site-specific surveys listed in Table 2.2 were undertaken in February 2018 to establish baseline sound levels in the vicinity of the proposed development. Survey locations and results are summarised in Section 3.
- 2.2.4 Details of the survey scope and methodology were discussed and agreed with Thurrock Council prior to deployment of the monitoring equipment. The scope, methodology, results of the survey, and figures showing surveys locations are set out in Volume 6, Appendix 11.1: Baseline Sound Monitoring Report.

2.3 Study area

- 2.3.1 There is no national government guidance or legislation on the extent of the study area to adopt for the assessment of noise effects from power generation infrastructure or the construction or operation of industrial facilities on NSRs. The study areas in this chapter have therefore been chosen on the basis of guidance contained within Design Manual for Roads and Bridges (DMRB), Volume 11, Section 3, Part 7: Noise and Vibration (Highways Agency et al., 2011), professional judgment of the distances over which significant noise effects may occur and consideration of the likely magnitude and duration of impact and the sensitivity of receptors.
- 2.3.2 During the construction and decommissioning phases, the study area for noise impacts considers NSRs within 500 m of the boundary of zones within which construction activity will occur. As the majority of construction activity will be concentrated within Zone A, an increased study area of 1 km from the boundary has been adopted for construction/decommissioning noise effects from within this zone. Locations of potentially sensitive receptors within this study area have been determined from Ordnance Survey data and the results of a desk based baseline assessment. The sensitivity of all NSRs within the chosen study area have been determined and predictions made at the worst affected receptors. Two NSRs have been identified within the study areas for construction/decommissioning noise with high sensitivity in accordance with Table 2.7; The Gateway Academy school, located approximately 150 m from the boundary of Zone J, and St James' Church, located approximately 250 m from the boundary of Zone I.
- 2.3.3 During the operational phase, the study area for noise impacts considers NSRs within 1 km of the main development site boundary. Locations of potentially sensitive receptors within this study area have been determined from Ordnance Survey data and the results of a desk based baseline assessment. The sensitivity of all NSRs within the chosen study area have been determined and predictions made at the worst affected receptors. One NSR has been identified within the study area for operational noise with high sensitivity in accordance with Table 2.7; St James' Church, located approximately 850 m from the main operational site boundary.
- It is not considered that vibration effects during the operational phase will be discernible 2.3.4 beyond the boundary of the proposed development. Given that levels of vibration attenuate very rapidly through the ground within a few metres and the approximate distance to the nearest receptor is >500 m from the main site boundary, it is considered that the operation of plant items will not cause significant adverse effect at any receptor.

- 2.3.5 During the construction phase of the proposed development, it is not considered that any significant vibration generating plant is likely to be used outside of Zone A. Percussive piling techniques may be utilised within Zone A, however, due to the distance between the boundary of Zone A and the nearest receptors (>500 m), it is not considered that this will give rise to significant adverse effect at any receptor.
- 2.3.6 HGV movements during the construction phase have the potential to cause vibration at receptors located adjacent to access routes, however it is considered that any effect would be negligible. Based on previous RPS measurements undertaken at dwellings located 5 m from the edge of a carriageway during an HGV pass-by, measured levels of vibration were below the level which might be just perceptible in residential environments, as given in BS 5228:2009+A1:2014 – Part 2: Vibration. Whilst levels of vibration are dependent on local ground conditions, it is considered that vibration from HGVs associated with the proposed development will not give rise to a significant adverse effect at any receptor.
- 2.3.7 Based on the above, it is considered appropriate to scope vibration effects out of further assessment. As such, study areas for vibration have not been assigned.
- 2.3.8 Noise sensitive ecological receptors have been identified within Volume 3, Chapter 9: Ecology.




Figure 2.1: Most affected receptors from construction and operational noise effects from Thurrock Flexible Generation Plant.

- 2.3.9 The locations of NSRs identified in the construction and operational assessments are shown in Figure 2.1.

Uncertainties and data limitations 2.4

Baseline sound survey data

- 2.4.1 Ambient and background sound levels are subject to seasonal variations due to a number of factors (e.g. wind and rain); the metrics derived from the noise monitoring, however, reduce the effects of seasonal variation. Baseline sound monitoring was undertaken in February 2018. As detailed in Section 3, a 'representative' background LA90 sound level has been adopted, which is considered to be representative of the background sound level during calm weather conditions (e.g. with little or no wind or precipitation) when background sound levels are likely to be lower. No significant seasonal variation in noise attenuation occurs.
- 2.4.2 Uncertainty due to instrumentation has been significantly reduced with the introduction of more modern instrumentation and is reduced further by undertaking field calibration checks on sound level meters before and after each measurement period and ensuring that all instrumentation is within accepted laboratory calibration intervals.

Construction methodology

2.4.2.1 Details of the indicative construction activities and phasing programme are provided in Volume 2, Chapter 2: Project Description. Whilst the specific number and type of plant and working methods cannot be specified at this stage, assumptions have been made based on professional judgement and experience with similar sites. The assessment has been based on typical construction activities for this type of infrastructure, using sound source terms from BS 5228-1:2009+A1:2014 and professional judgement. This is a standard approach and is considered to be an acceptable and robust method. Details on the assumed plant items are provided in Volume 6, Appendix 11.3: Construction Noise Assessment Methodology and Results.

Operational sound source data

2.4.3 A quantitative assessment has been undertaken based on source levels provided by the plant manufacturer and measurement data on similar types of equipment. Assumptions have been made based on the maximum design envelope parameters as detailed in Table 2.9.

Prediction methods and assessment

- 2.4.4 There are uncertainties in any prediction methodology. International Organisation for Standardization 9613 (ISO 9613) Part 2 (ISO, 1996) provides a method for predicting acoustic propagation outdoors. The method is applicable in practice to a great variety of sound sources and environments. It is applicable (directly or indirectly) to most situations including industrial sound sources, construction activities and many other ground-based sound sources. The estimated accuracy for values of the average downwind sound pressure level (LAT (DW)) is stated as +/-3 dB for a mean source/receptor height of up to five metres and source/propagation separation distance of up to 1 km. For a mean source height between 5 and 30 m, the estimated accuracy is given as +/-1 dB for a source/propagation separation distance of 0 to 100 m and +/-3 dB for a source/propagation separation distance of >100 m. This is a standard approach and is considered to be an acceptable prediction methodology.
- 2.4.5 With regard to subjective response, the noise standards adopted for the assessment will have been based upon the subjective response of the majority of the population or will be based upon the most likely response of the majority of the population. This is considered to be the best that can be achieved in a population of varying subjective response which will vary dependent upon a wide range of factors.

2.5 Impact assessment criteria

2.5.1 The significance of an effect is determined based on the magnitude of an impact and the sensitivity of the receptor affected by the impact. This section describes the criteria applied in this chapter to characterise the magnitude of potential impacts and sensitivity of receptors. The terms used to define magnitude and sensitivity are based on those used in the DMRB methodology, which is described in further detail in Volume 2, Chapter 4: Environmental Impact Assessment Methodology.

Magnitude

2.5.2 This section describes how the magnitude of impacts relating to noise and vibration have been identified for the construction, operational and maintenance, and decommissioning phases. The noise and vibration threshold criteria identified within this section have been used to inform the impact assessment criteria in Section 4 of this chapter.



Construction noise

2.5.3 The magnitude of construction noise impacts has been determined in accordance with Annex E of BS 5228-1:2009+A1:2014. The criteria for assessing noise impact from construction works have been based on Example Method 2 contained within Annex E.3.3 of BS 5228-1:2009+A1:2014; this indicates that:

> "Noise levels generated by site activities are deemed to be potentially significant if the total noise (pre-construction ambient plus site noise) exceeds the pre-construction ambient noise by 5 dB or more, subject to lower cut-off values of 65 dB, 55 dB and 45 dB L_{Aeg,T} from site noise alone, for the daytime, evening and night-time periods, respectively; and a duration of one month or more, unless works of a shorter duration are likely to result in significant effect."

2.5.4 Table 2.3 summarises the criteria that have been used for the assessment of construction noise impacts for residential dwellings and other NSRs of medium sensitivity, based on the guidance in BS 5228-1:2009+A1:2014. Determination of impact also includes consideration of duration, absolute noise levels and management of the noise sources, all of which make up the context. Professional judgement has been used when adopting the criteria in Table 2.3 for the assessment of high sensitivity receptors.

- 2.5.5 an activity per hour, the 'on-time'; and the attenuation of sound due to distance, ground attenuation and barrier effects. The assessment is based on reasonably expected construction phases as summarised in Volume 2, Chapter 2: Project Description, as well as plant items and on-times based on the information provided within BS 5228-1:2009+A1:2014. The average percentage on-time comes from estimates of the time that the plant will be operating at full power.
- 2.5.6 Where predicted construction noise levels are below ambient noise level or are 5 dB below the lower cut-off values for the relevant time period, or of short duration (<1 month), there is considered to be 'no change' or a negligible magnitude of impact.

2.5.7 For works of significant duration (>1 month) where predicted noise levels are up to 5 dB above ambient or are less than the lower cut-off values, this is considered to result in a minor magnitude of impact depending on the context and duration of the works. Where predicted noise levels are equal to the lower cut-off values or exceed them by up to 10 dB, this is considered to be a moderate magnitude of impact depending on the context and duration of the works. Predicted noise levels greater than 10 dB above the lower cut-off values are considered to result in a major magnitude of impact depending on the context and duration of the works.

Construction traffic

2.5.8 The noise changes identified in Table 2.4 have been used in the assessment of noise impacts associated with construction traffic on the local road network and from temporary diversion routes resulting from construction of the Thurrock Flexible Generation Plant. These are based on the guidance in DMRB, Volume 11, Section 3, Part 7 'Noise and Vibration' for the classification of magnitude of noise impacts in the short term. These DMRB criteria best reflect the temporary nature of the construction impacts; and allow for a robust, worst case assessment of response to construction traffic noise.

2.5.9 The magnitude of impact of the noise effects associated with the operation of the proposed development has been determined based upon the general methodology contained within BS 4141:2014. Following guidance contained within the Standard, the thresholds in Table 2.5 have been used to provide an initial evaluation of the magnitude of impact.

2.5.10 Whilst the level differences given in Table 2.5 are considered appropriate for determining an initial estimate of the noise impact from the proposed development at the nearest NSRs, further consideration has been given to the context of the sound which is a key requirement of the Standard, for example by referring to the examples of outcomes described within the NPPG, as summarised in Table 1.3.

2.5.11 The assessment of impact has considered the context of the sound source, including:

- the absolute level of the sound;
- of the specific sound; and
- conditions.
- These considerations comprise the context of any potential impact identified and will 2.5.12 inform the overall outcome of further assessment.

2.5.13 The operational noise magnitude of impact criteria presented in Table 2.5 are derived from BS 4142:2014 and, as such, are representative of noise impacts on residential premises. A non-residential, higher sensitivity receptor, St James' Church, has been identified within the operational noise study area. It is considered appropriate to use the criteria within Table 2.5 in conjunction with consideration of the specific requirements of this receptor in order to determine the magnitude of impact at this receptor.

Terms of magnitude used in this chapter

- 2.5.14 The criteria for defining magnitude in this chapter are outlined in Table 2.6. The magnitude of the impact is defined through consideration of the spatial extent, duration, frequency and reversibility of that impact. The descriptions in Table 2.6 inform professional judgement to pull together the disparate magnitudes of impact for construction, vibration and operation into a single magnitude of impact table.
- 2.5.15 There is no nationally adopted guidance to relate the numerical relative impact magnitude of noise from construction or industrial sites to the impact magnitude scale described above. There is evidence (Fritschi et al., 2011) that human response in terms of annoyance and sleep disturbance to noise from transportation sources is not linearly related to noise dose. Notwithstanding this, the noise assessment has adopted 5 dB steps in noise level to correspond to the divisions of the semantic scale based upon the following comment in Guidelines for Community Noise (WHO):

"The concept of an environmental noise impact analysis is central to the philosophy of managing environmental noise. Such an analysis should be required before implementing any project that would significantly increase the level of environmental noise in a community (typically, greater than a 5 dB increase)".

2.5.16 Based on professional judgement, it is considered that, for the construction phase, operational phase and decommissioning phase, short-term is defined as less than one month, medium term is defined as one month to two years and long term is defined as greater than two years. It is understood that each construction phase of the proposed development will have duration of approximately 18 months.

Sensitivity

2.5.17 There is no nationally adopted guidance on how the sensitivities of NSRs should be determined. Therefore, for this chapter, the sensitivity of classes of receptor is defined through consideration of the vulnerability, recoverability and value/importance of that receptor class. The criteria for defining sensitivity in this chapter are outlined in Table 2.7.

Significance

- 2.5.18 The significance of the effect with regards to noise is determined by correlating the magnitude of the impact and the sensitivity of the receptor. The particular method employed for this assessment is presented in Table 2.8. Where a range of significance of effect levels is presented in Table 2.8, the final assessment for each effect is based upon expert judgement.
- 2.5.19 As a guiding principle, the significance of effect has been ranked against the outcomes, as defined within the NPSE and PPGN, and summarised in Table 1.3. A significance of no change is considered to be below the NOEL. A significance of negligible or minor is considered to be below the LOAEL. A significance of moderate is considered to be between the LOAEL and SOAEL. A significance of major or substantial is considered to be above the SOAEL.
- 2.5.20 For the purpose of this assessment, any effects with a significance level of minor or less are considered to be **not significant** in EIA terms. Effects with a significance level of moderate are not automatically considered to be significant. Further consideration of the assessment outcome is given where a moderate effect is predicted before a determination of whether an effect is **significant/not significant** in EIA terms is made. Effects with a significance level of major are considered to be **significant** in EIA terms.

2.6 Maximum design envelope parameters for assessment

- 2.6.1 The maximum design envelope parameters identified in Table 2.9 have been selected as those having the potential to result in the greatest effect on an identified receptor or receptor group. These parameters have been identified based on the overview description of the development provided in Volume 2, Chapter 2: Project Description, including all potential development options where these are under consideration by the applicant. The NSRs included within the assessment have been identified from OS mapping and are listed in Volume 6, Appendix 11.3: Construction Noise Assessment Methodology and Results, and Appendix 11.4: Operational Noise Assessment Methodology and Results.
- Effects of greater adverse significance are not predicted to arise should any other 2.6.2 development scenario within the project design envelope be taken forward in the final design scheme.
- 2.6.3 layout and mitigation strategy of the proposed development.

2.7 Impacts scoped out of the assessment




Figure 2.2: Assumed operational plant site layout.

3. **Baseline environment**

3.1 **Current baseline**

Measured baseline sound levels

3.1.1 The measured baseline data are presented in Volume 6, Appendix 11.1: Baseline Sound Monitoring Report. A summary of the adopted sound levels for the day, evening and night-time periods at each survey location are presented in Table 3.1.

- 3.1.2 Construction activity associated with the proposed development is not anticipated to occur outside of daytime working hours. With the exception of survey location LT1, residual sound levels are below 60 dB LAeg during the day and are therefore subject to the criteria set within the lower cut-off values for the assessment of construction noise impacts (i.e. the most stringent limits). Despite a residual sound level of 61 dB LAeg at LT1, it is considered appropriate to use the lower cut-off values throughout the construction assessment. This follows a precautionary approach.
- 3.1.3 With regards to the assessment of operational noise impacts, BS 4142:2014 requires that the background sound levels adopted for the assessment be representative of the period being assessed. The Standard recommends that the background sound level should be derived from continuous measurements of normally not less than 15 minute intervals, which can be contiguous or disaggregated. However, the Standard also states that there is no 'single' background sound level that can be derived from such measurements.
- 3.1.4 The 25th percentile value (lower quartile) from the unattended monitoring has been used as a starting point in order to characterise the baseline sound environment. This value is not the lowest sound level encountered but is usually lower than obtained using the average. It therefore represents somewhere in the range of lower sound levels that are likely to be encountered and thus represents a precautionary assessment. Use of the 25th percentile also ensures that any periods during which higher wind speeds could have affected the measured baseline noise levels do not unduly affect the analysis.
- 3.1.5 The adopted representative survey locations for the nearest affected receptors during the operational phase of the proposed development are presented in Table 3.2. These receptors have been identified as the likely worst affected receptors during the operational phase of the proposed development. With the exception of St James' Church which has been identified as a high sensitivity receptor, all other receptors are considered to be of medium sensitivity.

- 3.1.6 The receptors identified in Table 3.2 represent the wider body of receptors within the chosen study area for operational noise. It is considered that effects of greater significance than those predicted at the identified receptors will not occur at any other receptor within the study area.
- 3.1.7 For the construction assessment, receptors for which the highest noise levels are predicted during each construction activity are presented. Receptors of high sensitivity are considered separately to determine whether a greater significance of effect would occur at these receptors. In order to present a robust assessment, the lower cut-off values as given in BS 5229:2009+A1:2014 have been taken as thresholds for the assessment of construction noise.

3.2 **Future baseline**

- 3.2.1 No significant change to the future baseline scenario, in the absence of Thurrock Flexible Generation Plant, is anticipated.
- 3.2.2 There is no evidence to suggest receptors would be introduced which would be closer than those which have been assessed; therefore, the adopted baseline assumptions are considered representative of the future baseline conditions over the operational life of the proposed development.
- 3.2.3 The future baseline traffic data indicate that there would be a minor increase in baseline noise levels from road traffic due to natural growth. However, the increases are very low and are unlikely to have an influence on the assessment.

Climate change

- 3.2.4 The Met Office UK Carbon Projections ('UKCP09') dataset¹ provides probabilistic projections of change in climatic parameters over time for 25 km grid squares across the UK. Projected changes during low, medium and high future global greenhouse gas emissions scenarios have been reviewed for the period from 2020 up to 2069, encompassing the potential six year construction and 35 year operational periods of the proposed development.
- 3.2.5 The likely ranges of change in climatic parameters including precipitation, temperature, wind speed, humidity and frequency of extreme weather are not considered to materially affect the future baseline described above for noise and vibration or increase the sensitivity of receptors to impacts beyond that described in Section 4.

¹ CP09 is presently being updated to CP18, expected to be published in November 2018 (Met Office, 2018). CP09 remains the most up-to-date available data and remains an appropriate tool for adaptation planning (Met Office, 2017).





4. Assessment of effects

Construction phase 4.1

4.1.1 The impacts of the construction phase of Thurrock Flexible Generation Plant have been assessed with regards to noise impact in accordance with the maximum design envelope parameters as described in Table 2.9.

Construction noise

Magnitude of impact

- 4.1.2 This section contains details on the magnitude of the impact of construction activity associated with the proposed development.




Figure 4.1:Construction – Trenching for gas pipeline Zone E.

- 4.1.3 The noise modelling assumptions, predictions and results of the assessment are presented in Volume 6, Appendix 11.3: Construction Noise Assessment Methodology and Results. A summary of the outcome is provided below. Construction noise contours for each activity are presented in Figure 4.1 to Figure 4.17.
- 4.1.4 Predictions have shown that predicted noise levels from the majority of construction activity associated with the proposed development will be below the lower cut-off value during the day of 65 dB LAeq, as given in Method 2 within Annex E of BS 5228-1:2009+A1:2014.
- 4.1.5 The highest predicted noise levels are from the construction of the haul road within Zone J, with levels of 66 dB L_{Aeq,T} predicted at the façade of receptors along Biggin Lane. In accordance with the magnitude of impact criteria as detailed in Table 2.3, this is representative of a moderate magnitude of impact at these receptors. Predictions are based on construction activity occurring in the worst case positions within Zone J and, as such, consideration must be given for activity moving across the construction area as work progresses.
- 4.1.6 All other proposed construction activities will result in noise levels greater more than 5 dB below the lower cut-off value during the day of 65 dB LAeg (i.e. below 60 dB LAeg). In accordance with the magnitude of impact criteria as detailed in Table 2.3, this is representative of a negligible magnitude of impact at these receptors.
- 4.1.7 The highest predicted noise level at the Gateway Academy school is 43 dB LAeq, during the construction of the haul road within Zone J. In accordance with the magnitude of impact criteria as detailed in Table 2.3, this is representative of a negligible magnitude of impact at this receptor.

- 4.1.8 The highest predicted noise level at St James' Church is 47 dB LAeg, during the construction of the haul road within Zone I. In accordance with the magnitude of impact criteria as detailed in Table 2.3, this is representative of a negligible magnitude of impact at this receptor.
- 4.1.9 Certain construction activities have the potential to overlap, resulting in a cumulative noise impact upon receptors. At this stage of the proposed development, a detailed construction programme is not realistically available. Predicted noise levels, as given in Volume 6, Appendix 11.3: Construction Noise Assessment Methodology and Results, are based on the worst case position of construction plant, adjacent to receptors on the boundary of the associated zone. In practice, noise levels from construction will likely vary as construction progresses and plant items move across the site. Therefore, based on the above, whilst combined effects from different construction activities may result in an increase in noise levels, it is not considered that this will result in an exceedance of the daytime cut-off value for a period greater than one month.
- 4.1.10 Based on the above, it is considered that noise from construction activity associated with the proposed development will result in a moderate magnitude of impact at the worst affected NSRs.
- 4.1.11 It is considered that noise impacts from construction activity associated with the proposed development on users of PRoWs would be negligible. Whilst users of these PRoWs might experience elevated noise levels for short periods when walking within these areas, this is not considered a mechanism for significant effect. Users of the PRoWs would only experience transitory exposure to elevated noise levels from construction activity associated with Thurrock Flexible Generation Plant.
- 4.1.12 Noise impacts from construction activity on sensitive ecological receptors are considered in Volume 3, Chapter 9: Ecology.

Sensitivity of the receptor

4.1.13 The noise sensitive receptors identified within the construction assessment have a sensitivity considered to be **medium**. As discussed in 2.3.2, the nearest NSRs identified for the assessment of construction noise impacts are considered representative of the worst affected receptors likely to be affected by the construction of the proposed development. Whilst two receptors of high sensitivity have been identified within the study area, predictions have shown that noise impact from construction at these receptors would be negligible. As such, the determination of significance is based on the most affected medium sensitivity receptors.





Significance of effect

- 4.1.14 Overall, it is predicted that a **moderate** impact on the **medium** sensitivity receptors would result in a **moderate** adverse effect. This is equivalent of noise levels between the LOAEL and SOAEL.
- 4.1.15 A moderate effect is predicted only during the construction of the haul road at Zone J. Predictions have been made based on construction activity occurring at the worst case position within this zone and therefore do not take into account works moving across the site as construction progresses. As such, predicted noise levels are only likely to be experienced for a relatively short duration. During all other construction activity, predicted noise levels will be more than 5 dB below the BS 5228 lower cut-off value during the day.
- Based on the above, it is considered that the moderate adverse effect is **not** 4.1.16 significant in EIA terms.

Further mitigation or enhancement

No significant adverse effects have been predicted and no further mitigation is 4.1.17 considered to be required.

Construction traffic

Magnitude of impact

- 4.1.18 This section contains details on the magnitude of the impact of construction traffic associated with the proposed development.
- 4.1.19 The potential noise change on the surrounding highway network, occurring as a result of increased traffic flow during the peak construction period of the proposed development, has been predicted and assessed against the noise change criteria as given in Table 2.4.
- The assessment methodology and results are presented in Volume 6, Appendix 11.3: 4.1.20 Construction Noise Assessment Methodology and Results. A summary of the results is provided below.

During the peak construction period, a noise change of 2.1 dB is predicted on road link 4.1.21 11 (Coopers Shaw Road, Church Road, Station Road - between Gun Hill Road and EMR East Tilbury Junction) during the night time period. In accordance with the magnitude of impact criteria in Table 2.4, this is representative of a **minor** impact. A minor magnitude of impact is also predicted along road links 10 and 12 (Gun Hill Road - between Coopers Shaw Road and Turnpike Lane, and Turnpike Lane - between Gun Hill Road and Linford Road) during the night. Noise change of negligible impact is predicted along all other construction access road links during the day and night periods.

Sensitivity of the receptor

4.1.22 There are a number of NSRs located along Turnpike Lane, Gun Hill Road, Coopers Shaw Road, Church Road and Station Road, the majority of which are medium sensitivity residential receptors. There are no high sensitivity receptors identified adjacent to these access routes.

Significance of effect

4.1.23 Overall, it is predicted that a **minor** impact on the **medium** sensitivity receptors would result in a minor adverse effect, which is not significant in EIA terms. This is equivalent of noise levels below the LOAEL.

Further mitigation or enhancement

4.1.24 No significant adverse effects have been predicted and no further mitigation is considered to be required.

Future monitoring

4.1.25 No noise monitoring to test the predictions made within the construction impact assessment is considered necessary.




Figure 4.2:Construction – Trenching for gas pipeline Zone D.




Figure 4.3:Construction – Trenching for gas pipeline Zone C.




Figure 4.4: Construction – Site clearance Zone A.




Figure 4.5: Construction – Piling Zone A.




Figure 4.6: Construction – Installation of plant items Zone A.




Figure 4.7: Construction – HDD drilling Zone C, location 1.








Figure 4.8: Construction – HDD drilling Zone C, location 2.





Figure 4.9: Construction – Above ground gas connection building construction Zone E.
















Figure 4.11: Construction – General activity within compound Zone C.








Figure 4.12: Construction – Erection and fit-out of buildings Zone A.








Figure 4.13: Construction – Earthworks and foundations Zone A.




Figure 4.14: Construction – Construction of haul roads Zone J, west.






Figure 4.15: Construction – Construction of haul roads Zone J, east.








Figure 4.16: Construction – Construction of haul roads Zone I.




Figure 4.17: Construction – Construction of haul roads Zone C.

4.2 **Operational phase**

4.2.1 The impacts of the operation of Thurrock Flexible Generation Plant have been assessed with regards to noise impact in accordance with the maximum design envelope parameters as described in Table 2.9.

Magnitude of impact

- 4.2.2 This section contains details on the magnitude of the impact of the operational phase of the proposed development.




Figure 4.18: Operational noise contour, day.




Figure 4.19: Operational noise contour, night.

- 4.2.3 The noise modelling assumptions, predictions, context and results of the BS 4142:2014 assessment and noise change assessment are presented in Volume 6, Appendix 11.4: Operational Noise Assessment Methodology and Results. A summary of the outcome is provided below. Operational noise contours are provided in Figure 4.18 and Figure 4.19.
- It is the daytime and evening periods that are of greatest concern with respect to the 4.2.4 impact on quality of life (amenity, enjoyment of property etc.). This is because people will tend to be indoors or asleep during the night, whereas, during the day and evening, they are more likely to be using outdoor spaces for amenity purposes. It should also be noted that the proposed development is not expected to operate frequently during the night-time.
- 4.2.5 The results of the BS 4142:2014 assessment have shown that during the day, a negligible impact is predicted at all NSRs. During the evening, a minor impact is predicted at the most affected NSRs. During the night, a moderate impact is predicted at the most affected NSR, Havers Lodge. The final determination of magnitude of impact is based on the consideration of the context.
- 4.2.6 It has been established that sound arising from the operation of the proposed development will not result in ambient noise level increases at any of the nearest NSRs during the day, and an increase of only 1 dB during the evening and night-time. It is therefore considered that the results of the noise change assessment show that the operation of the proposed development is unlikely to seriously affect the health or quality of life of those in close proximity to the site.
- 4.2.7 In terms of the absolute noise level assessment, sound from the proposed development will not contribute to, or give rise to, adverse impacts on NSRs during the daytime or evening.

- 4.2.8 The level for the onset of sleep disturbance during the night-time (i.e. lowest observed adverse effect level) contained in the WHO Guidance is 45 dB LAeq (façade), equivalent to a free-field level of 42 dB LAeq. In the unlikely event of the proposed development operating at night, ambient noise with the flexible generation plant in operation will have a negligible contribution, if any, to ambient noise levels. It is therefore considered that the operation of the proposed development will not result in any significant impact based on WHO absolute noise criteria for sleep disturbance.
- 4.2.9 Taking both the change in noise levels and the absolute sound levels during the day and night into consideration, it is considered that sound from the facility will not result in any adverse impacts on the quality of life of residents nearby.
- 4.2.10 On the basis of the above, it is considered appropriate to reduce the impact at Havers Lodge during the night time, based on the results of the BS 4142:2014 assessment, from moderate to minor. As such, levels of sound arising from the operation of the proposed development will result in a minor magnitude of impact at the worst affected NSRs during the evening and night-time periods. It is considered that noise from site has been mitigated and minimised through the application of best available techniques to be as low as practicable.
- 4.2.11 It is considered that noise impacts from the operation of the proposed development on users of PROW would be negligible. Whilst users of these PROW might experience elevated noise levels for short periods when walking within these areas, this is not considered a mechanism for significant effect. Users of the PROW would only experience transitory exposure to elevated noise levels from operational noise emissions from Thurrock Flexible Generation Plant.
- 4.2.12 Noise impacts from the operation of the proposed development on sensitive ecological receptors are considered in Volume 3, Chapter 9: Ecology.

Sensitivity of the receptor

4.2.13 Predictions have demonstrated a minor magnitude of impact during the evening and night at St James' Church which has been identified as a **high** sensitivity receptor. All other NSRs identified within the operational assessment have a sensitivity considered to be medium. As discussed in paragraph 2.3.3, the nearest NSRs identified for the assessment of operational noise impacts are considered representative of the most affected receptors likely to be affected by the operation of the proposed development.





Significance of effect

- 4.2.14 At St James' Church it is predicted that a **minor** impact on a **high** sensitivity receptor would result in a **minor or moderate** adverse effect. Based on the supporting context of the assessment, as discussed in paragraphs 4.2.6 to 4.2.8, it is considered that this would tend towards a **minor** adverse effect. This is considered **not significant** in EIA terms. This is equivalent of noise levels below the LOAEL.
- 4.2.15 At all other receptors, it is predicted that a **minor** impact on **medium** sensitivity receptors would result in a **minor** adverse effect, which is **not significant** in EIA terms. This is equivalent of noise levels below the LOAEL.

Further mitigation or enhancement

4.2.16 No significant adverse effects have been predicted and no further mitigation is considered to be required.

Future monitoring

4.2.17 No noise monitoring to test the predictions made within the operational impact assessment is considered necessary.

Decommissioning phase 4.3

- 4.3.1 The impacts of the decommissioning of Thurrock Flexible Generation Plant have been assessed with regards to noise impact in accordance with the maximum design envelope parameters as described in Table 2.9.
- 4.3.2 During decommissioning, the equipment and activities used are likely to be broadly similar to those used during construction. It is possible that technology advances will result in quieter equipment being available for these tasks.

Magnitude of impact

- 4.3.3 It is anticipated that noise impacts would be no greater than those predicted during the construction phase. The majority of decommissioning activity will likely occur within Zone A and, as such, construction noise predictions along haul roads are not considered representative of work to be undertaken during this phase. The determination of decommissioning noise impacts has not therefore considered works within Zone J.
- 4.3.4 The results of the construction assessment indicate that the magnitude of impact at the worst affected NSRs will be negligible.

Sensitivity of the receptor

4.3.5 The noise sensitive receptors identified within the decommissioning assessment are the same as those within the construction assessment. A negligible magnitude of impact is predicted at St James' Church which is considered to be high sensitivity. All other receptors are considered to be medium sensitivity.

Significance of effect

At St James' Church, it is predicted that negligible impact on a high sensitivity receptor 4.3.6 would result in a minor adverse effect, which is not significant in EIA terms. This is considered to represent the most affected receptor during the decommissioning phase. This is equivalent of noise levels below the LOAEL.

Further mitigation or enhancement

No significant adverse effects have been predicted and no further mitigation is 4.3.7 considered to be required.

Future monitoring

4.3.8 No noise monitoring to test the predictions made within the decommissioning impact assessment is considered necessary.

Transboundary effects 4.4

4.4.1 A screening of transboundary impacts has been carried out and is presented in Volume 5, Appendix 4.2: Transboundary Impacts Screening Note. This screening exercise identified that there was no potential for significant transboundary effects with regard to noise and vibration from Thurrock Flexible Generation Plant upon the interests of other EEA States.

Inter-related effects 4.5

4.5.1 Inter-relationships are considered to be the impacts and associated effects of different aspects of the construction, operation or decommissioning of Thurrock Flexible Generation Plant on the same receptor. The following assessments have been made and a description of the likely inter-related effects on noise and vibration is provided in Volume 4, Chapter 17: Summary of Inter-Related Effects.

Project lifetime effects

4.5.2 Assessment of the potential for effects that occur during more than one stage of the development's lifetime (construction, operation or decommissioning) to interact such that they may create a more significant effect on a receptor than when assessed in isolation for each stage

Receptor-led effects

4.5.3 Assessment of the potential for effects via multiple environmental or social pathways to interact, spatially and temporally, to create a greater inter-related effect on a receptor than is predicted for each pathway (in its respective topic chapter) individually.





5. **Cumulative effects assessment**

5.1 Introduction

- 5.1.1 The process of identifying other consented or proposed developments and screening to create a shortlist of those having potential for cumulative effects with Thurrock Flexible Generation Plant is described in Volume 5, Appendix 4.1: Cumulative Developments and Screening. Appendix 4.1 lists the shortlisted cumulative developments and the tier they have been assigned (guiding the weight that the decision-maker may place on each development's likelihood of being realised) in accordance with PINS Guidance Note 17.
- 5.1.2 Cumulative developments shortlisted are those that have potential to contribute to impacts affecting receptors also affected by the proposed development (for example, contributing significant additional traffic to the same road links), or that introduce additional sensitive receptors (for example, new residences or schools closer to the proposed development than existing), or both.
- 5.1.3 The cumulative effects assessment for noise and vibration has been undertaken in two stages, reported as follows. In the first stage, cumulative effects of the proposed development have been considered in an overall scenario where the land surrounding the proposed development could be largely transformed by three adjacent NSIP developments and the possible expansion of nearby residential and employment uses to the east. This is referred to as the 'max development' scenario.
- 5.1.4 In the second stage, cumulative effects with specific individual development projects have been assessed where these would affect a particular environmental pathway or receptor for noise and vibration. Only shortlisted developments with potential cumulative effects specific to noise and vibration are assessed in this chapter.

5.2 Cumulative effects in 'max development' scenario

- 5.2.1 Three NSIP developments are proposed on land adjacent to and in some cases overlapping with the Thurrock Flexible Generation Plant application boundary. The Tilbury2 port expansion adjacent to the west is at examination stage (Tier 1). The Tilbury Energy Centre (TEC) power station to the south and Lower Thames Crossing (LTC) motorway and link road to the east and north are both at EIA scoping stage (Tier 2).
- 5.2.2 Outline planning permission has been granted for several residential and mixed-use developments expanding Linford and East Tilbury in the direction of Thurrock Flexible Generation Plant (Tier 1).

- 5.2.3 Should all of these developments proceed, Thurrock Flexible Generation Plant's main development site would be closely surrounded on all sides by the temporary or permanent works areas of the NSIPs. Its gas connection point to Feeder 18 could be adjacent to the expanded outskirts of East Tilbury and also potentially to the TEC gas connection, and the pipeline route could cross land to be developed for the LTC.
- The Thurrock Core Strategy (2015) allocates land for possible strategic employment 5.2.4 provision and sustainable economic growth to the west of the proposed development and to the east where there is existing industry at East Tilbury. Thurrock Borough Council is drafting a new Local Plan to replace the Core Strategy. The Issues and Options (Stage 2) consultation document proposals map of July 2018 (withdrawn temporarily due to recent NPPF changes) suggested possible zones for residential and commercial/employment development in areas east of the proposed development, where this would be facilitated by the Lower Thames Crossing project. However, these Tier 3 development possibilities are afforded only limited weight due to the early stage of this local plan development process.
- 5.2.5 In the 'max development' scenario set out in paragraphs 5.2.1 to 5.2.3 above, the noise and vibration effects of Thurrock Flexible Generation Plant would likely be negligible in the context of cumulative noise and vibration impact from the other proposed developments. Due to the low predicted noise impact from the Thurrock Flexible Generation Plant (minor adverse effect at the worst affected receptors during the operational phase), and the scale of the development in comparison to Tilbury2, TEC and LTC, it is considered that the contribution of Thurrock Flexible Generation Plant to any potential cumulative effect would be negligible.
- 5.2.6 During the construction phase of Thurrock Flexible Generation Plant, effects of moderate significance are predicted at the worst affected receptors from the proposed development alone. At this stage, sufficient information is not available on the proposed construction periods of TEC or LTC. It has been noted that there is likely to be limited overlap in the construction periods of Tilbury2 and Thurrock Flexible Generation Plant. It is considered that whilst overlaps in the construction periods of the other proposed developments and Thurrock Flexible Generation Plant may occur, noise effects from the Thurrock Flexible Generation Plant could be controlled to ensure that it would not make any material contribution to a significant cumulative noise effect.





Cumulative effects with specific developments 5.3

5.3.1 The following shortlisted developments have been identified as having the potential to result in significant cumulative noise effects in combination with Thurrock Flexible Generation Plant regarding noise and vibration. Where insufficient information exists on the other proposed developments to carry out a detailed cumulative assessment, consideration has instead been given to the potential for significant cumulative effects based on professional judgement.

Tilbury2

Construction

- 5.3.2 There is likely to be limited overlap in the construction periods of Tilbury2 and Thurrock Flexible Generation Plant. Where overlap does occur, this is likely to result in an increased noise effect at any one receptor for only a short duration. Whilst effects of moderate significance are predicted at the worst affected receptors during the construction phase of Thurrock Flexible Generation Plant, these are not considered to be significant. It is considered that any overlap in construction activity would likely be of short duration and therefore any cumulative noise effects would not be likely to be significant.
- 5.3.3 Vibration effects resulting from construction associated with Thurrock Flexible Generation Plant would be likely to be negligible. It is not considered that a negligible contribution to a cumulative impact would result in an increase of significance of effect at affected receptors.
- 5.3.4 Traffic flow predictions from Thurrock Flexible Generation Plant in combination with predicted cumulative traffic flows from other proposed developments show that noise from construction traffic would result in impacts no greater than minor at receptors located adjacent to identified construction access routes.

Operation

5.3.5 Noise effects from the principal sources of operational noise associated with Tilbury2 are predicted to result in major adverse effects at the worst affected receptors. Predicted noise levels at the worst affected receptors from the operation of Tilbury2 are considerably higher than those from Thurrock Flexible Generation Plant. It is therefore considered that any contribution from Thurrock Flexible Generation Plant to a cumulative impact during the operational phase of both developments at affected NSRs would be negligible and therefore unlikely to result in an increase of significance of effect at any receptor.

- 5.3.6 Vibration effects resulting from the operation of Thurrock Flexible Generation Plant would likely be negligible. It is not considered that a negligible contribution to a cumulative impact would result in an increase of significance of effect at affected receptors.
- 5.3.7 It is considered that any contribution to cumulative noise and vibration effects from operational traffic associated with Thurrock Flexible Generation Plant would be negligible and unlikely to result in an increased significance of effect.

Decommissioning

5.3.8 Decommissioning effects are considered to be similar to those predicted during construction. As such, it is considered that the decommissioning of Tilbury2 is unlikely to result in significance cumulative noise effects at affected NSRs.

Tilbury Energy Centre

Construction

- 5.3.9 There is insufficient information available at this stage on the proposed construction period or phasing of TEC. As such, it is not possible to determine whether the construction periods for TEC and Thurrock Flexible Generation Plant would overlap. It is considered that overlap between the construction periods of the two developments has the potential to result in cumulative effects at NSRs particularly to the east of the development where construction for the TEC gas pipeline will pass within close proximity of residences.
- 5.3.10 Predictions have shown that noise effects from the construction of Thurrock Flexible Generation Plant will be of moderate significance at the worst affected NSRs. Any temporal overlap in construction activities is likely to be of short duration. It is considered that the construction of TEC is unlikely to result in significant cumulative noise effects at affected NSRs.
- 5.3.11 Vibration effects resulting from construction associated with Thurrock Flexible Generation Plant would be likely to be negligible. It is not considered that a negligible contribution to a cumulative impact would result in an increase of significance of effect at affected receptors.
- 5.3.12 Traffic flow predictions from Thurrock Flexible Generation Plant in combination with predicted cumulative traffic flows from other proposed developments show that noise from construction traffic would result in impacts no greater than minor at receptors located adjacent to identified construction access routes.



Operation

- 5.3.13 At this stage, an assessment of the potential noise impact from the operation of TEC has yet to be undertaken.
- 5.3.14 It is understood that current plans for TEC include noise generating plant items such as combined cycle gas turbines (CCGT), open cycle gas turbines (OCGT) and battery storage units. The addition of noise generating operational plant items will require the developer to consider the potential for significant effects from operational noise both alone and cumulatively. It is considered that any contribution from Thurrock Flexible Generation Plant to a cumulative operational noise impact at affected NSRs would be negligible.
- 5.3.15 Vibration effects resulting from the operation of Thurrock Flexible Generation Plant would likely be negligible. It is not considered that a negligible contribution to a cumulative impact would result in an increase of significance of effect at affected receptors.
- 5.3.16 It is considered that any contribution to cumulative noise and vibration effects from operational traffic associated with Thurrock Flexible Generation Plant would be negligible and unlikely to result in an increased significance of effect.

Decommissioning

Decommissioning effects are considered to be similar to those predicted during 5.3.17 construction. As such, it is considered that the decommissioning of TEC is unlikely to result in significance cumulative noise effects at affected NSRs.

Lower Thames Crossing

Construction

- There is insufficient information available at this stage on the proposed construction 5.3.18 period or phasing of LTC. As such, it is not possible to determine whether the construction periods for LTC and Thurrock Flexible Generation Plant would overlap. It is considered that overlap between the construction periods of the two developments has the potential to result in cumulative effects at NSRs.
- 5319 Predictions have shown that noise effects from the construction of Thurrock Flexible Generation Plant will be of moderate significance at the worst affected NSRs. It is considered that any contribution from Thurrock Flexible Generation Plant to a cumulative impact during the construction phases of the two developments at affected NSRs would be negligible.

- 5.3.20 Vibration effects resulting from construction associated with Thurrock Flexible Generation Plant would likely be negligible. It is not considered that a negligible contribution to a cumulative impact would result in an increase of significance of effect at affected receptors.
- 5.3.21 Traffic flow predictions from Thurrock Flexible Generation Plant in combination with predicted cumulative traffic flows from other proposed developments show that noise from construction traffic would result in impacts no greater than minor at receptors located adjacent to identified construction access routes.

Operation

- 5.3.22 At this stage, an assessment of the potential noise impact from the operation of LTC has yet to be undertaken.
- 5.3.23 Increased vehicle movements as a result of increased traffic flow across the LTC may mask noise from Thurrock Flexible Generation Plant therefore resulting in a lesser perceived effect of operational noise from the proposed development.
- There is the potential for static plant items associated with the LTC development, such 5.3.24 as tunnel ventilation fans, to result in a cumulative noise impact with the operation Thurrock Flexible Generation Plant. The addition of noise generating operational plant items will require the developer to consider the potential for significant effects from operational noise both alone and cumulatively.
- 5.3.25 Vibration effects resulting from the operation of Thurrock Flexible Generation Plant would likely be negligible. It is not considered that a negligible contribution to a cumulative impact would result in an increase of significance of effect at affected receptors.
- 5.3.26 It is considered that any contribution to cumulative noise and vibration effects from operational traffic associated with Thurrock Flexible Generation Plant would be negligible and unlikely to result in an increased significance of effect.

Decommissioning

5.3.27 Decommissioning effects are considered to be similar to those predicted during construction.





Conclusion and summary 6.

The results of the noise and vibration assessment undertaken for the proposed 6.1.1 development are summarised in this section.

Construction noise

- 6.1.2 An assessment of the potential effects of noise from construction activity associated with the proposed development has been undertaken. The methodology and results are presented in Volume 6, Appendix 11.3: Construction Noise Assessment Methodology and Results.
- 6.1.3 Predictions have shown that noise from construction activity will result in a moderate magnitude of impact at the most affected receptors. The most affected receptors are considered to be of medium sensitivity. A moderate impact on the medium sensitivity receptors would result in a moderate adverse effect. Based on the outcome of the assessment and the context surrounding the predictions, it is determined that a moderate adverse effect in this instance is **not significant** in EIA terms.

Construction traffic

- 6.1.4 An assessment of the potential effects of noise from construction traffic associated with the proposed development has been undertaken. The methodology and results are presented in Volume 6, Appendix 11.3: Construction Noise Assessment Methodology and Results.
- 6.1.5 Predictions show that noise change on the local highway network associated with the proposed development will result in a **minor** magnitude of impact at receptors located adjacent to construction access routes. Receptors along affected routes have been identified as **medium** sensitivity. A minor impact on the medium sensitivity receptors will result in a minor adverse effect, which is **not significant** in EIA terms.

Operational noise

6.1.6 An assessment of the potential effects of noise from the operation of the proposed development has been undertaken. The methodology and results are presented in Volume 6, Appendix 11.4: Operational Noise Assessment Methodology and Results.

6.1.7 Predictions have shown that noise from the operation of the proposed development will result in a minor magnitude of impact at the worst affected receptors. The worst affected receptors are considered to be of high sensitivity. A minor impact on the high sensitivity receptor would result in a minor or moderate adverse effect. Based on the context surrounding the predictions, it is determined that this will tend towards a minor adverse effect, which is not significant in EIA terms.

Decommissioning noise

- 6.1.8 It is considered that the noise effects from decommissioning activity will be similar to those during the construction phase, with the exception of haul road construction activity within Zone J. Predictions from the construction assessment are therefore considered broadly representative of the decommissioning phase with the exception of this activity. The methodology and results of the construction assessment are presented in Volume 6, Appendix 11.3: Construction Noise Assessment Methodology and Results.
- 6.1.9 Predictions have shown that noise from construction activity, considered representative of decommissioning activity, will result in a negligible magnitude of impact at the most affected receptors. The most affected receptors are considered to be of high sensitivity. A negligible impact on the high sensitivity receptors would result in a **minor** adverse effect, which is **not significant** in EIA terms.

Cumulative effects

- 6.1.10 An assessment of the potential cumulative effects of noise from the construction, operation and decommissioning of Thurrock Flexible Generation Plant and other identified proposed developments in the wider area has been undertaken.
- 6.1.11 It has been determined that the contribution from Thurrock Flexible Generation Plant to any cumulative effect with the other proposed developments would be minimal. As such, it is considered that during any phase of Thurrock Flexible Generation Plant, the contribution from the development to any cumulative effect will not result in an increased significance of effect at any NSRs.

Next Steps 6.2

6.2.1 Following review of this PEIR document and further consultation with the relevant stakeholders, the noise and vibration assessment and chapter will be reviewed and updated to form part of the ES. It is not considered that any additional surveys are required prior to completion of the ES document.
