The Thurrock Flexible Generation Plant Development Consent Order 2022 ("the DCO") – Non-Material Change ("NMC") Application

Please find enclosed an application for a non-material change to The Thurrock Flexible Generation Plant Development Consent Order 2022 (S.I. 2022 no. 157). The enclosed application has been prepared in accordance with the Planning Act 2008, the Infrastructure Planning (Changes to, and Revocation of, Development Consent Orders) Regulation 2011 (as amended) and the Guidance on Changes to Development Consent Orders.

The enclosures with this letter are:

- 1) An application statement explaining the proposal. This statement includes:
 - a. Background to the application;
 - b. The nature and materiality of the change sought; and
 - c. The statement required pursuant to Regulation 7(A)1 concerning publicising and duty to consult.
- 2) A copy of the Regulation 6 notice, which is to be published in the Thurrock Gazette and the Gravesend Messenger on 15 and 22 February 2024, with a consultation response end date of 22 March 2024.
- 3) A draft amendment order.
- 4) A tracked changes version of the DCO showing the amendments sought.









In respect of the information required by Regulation 4(2):

- a. The Applicant is Thurrock Flexible Generation Limited whose registered office is 4th Floor, 80 Victoria Street, London, SW1E 5JL and is specified as the "undertaker" in the DCO (albeit since the grant of the DCO the name of the undertaker has been changed from "Thurrock Power Limited");
- b. There is no agent for this application;
- c. The DCO reference was EN010092;
- d. Details of the change applied for are in the application statement;
- e. The documentation considered necessary to support the application is contained in the application statement or the accompanying Amendment Order and tracked changes DCO
- f. The Applicant is the entity who applied for the DCO to which the application relates and has a lease over part of the site;
- g. The statement referred to in Regulation 7A is within the application statement; and
- h. No paper copies of the application have been requested.

We will provide confirmation of the publication of the notices in the press following publication and will be writing to all consultees on 14 February 2024, advising of the submission of the application and providing them with the required details to enable them to respond. As indicated above the response deadline is 11.59pm on Friday 22 March 2024.
